Update on the execution of the buy-back programme

With reference to the buy-back programme approved by the shareholders on 8 May 2012 and launched on 8 June 2012, Sabaf S.p.A. informs that in the period between 3 September 2012 and 7 September 2012 acquired no. 15,800 treasury shares at an average unit price of € 7.7232 per share, for a total amount of € 122,026.71.
