Update on the execution of the buy-back programme

With reference to the buy-back programme approved by the shareholders on 8 May 2012 and launched on 8 June 2012, Sabaf S.p.A. informs that in the period between 1 October 2012 and 5 October 2012 acquired no. 15,000 treasury shares at an average unit price of \leq 9.0321 per share, for a total amount of \leq 135,480.80.
