## Update on the execution of the buy-back programme

With reference to the buy-back programme approved by the shareholders on 8 May 2012 and launched on 8 June 2012, Sabaf S.p.A. informs that in the period between 12 November 2012 and 16 November 2012 acquired no. 11,897 treasury shares at an average unit price of € 8.2561 per share, for a total amount of € 98,222.42.
