Update on the execution of the buy-back programme

With reference to the buy-back programme approved by the shareholders on 8 May 2012 and launched on 8 June 2012, Sabaf S.p.A. informs that in the period between 24 December 2012 and 28 December 2012 acquired no. 3,300 treasury shares at an average unit price of € 8.7343 per share, for a total amount of € 28,823.29.
