## Update on the execution of the buy-back programme

With reference to the buy-back programme approved by the shareholders on 8 May 2012 and launched on 8 June 2012, Sabaf S.p.A. informs that in the period between 7 January 2013 and 11 January 2013 acquired no. 7,050 treasury shares at an average unit price of € 9.2071 per share, for a total amount of € 64,910.38.
