**GIUSEPPE SALERI S.a.p.A. SELLS 4.99% STAKE IN SABAF**

Sabaf S.p.A. hereby announces that it has been informed by parent company Giuseppe Saleri S.a.p.A. that through off-market transactions from 21 to 26 June, the latter sold 575,000 Sabaf shares, corresponding to 4.99% of the share capital. These shares were sold at a price of Euro 9.243 per share to asset management companies Fidelity Worldwide Investment, which purchased 1.82%, and Fidelity Management and Research, which purchased 3.17%.
