

## Update on the execution of the buy-back programme

With reference to the buy-back programme approved by the shareholders on 6 May 2021 and 28 April 2022, and launched on 4 April 2022, Sabaf S.p.A. informs that in the period between 18 July 2022 and 22 July 2022 acquired no. 2,062 treasury shares at an average unit price of € 23.4055 per share, for a total amount of € 48,317.17.
