

## Update on the execution of the buy-back programme

With reference to the buy-back programme approved by the shareholders on 6 May 2021 and 28 April 2022, and launched on 4 April 2022, Sabaf S.p.A. informs that in the period between 31 October 2022 and 4 November 2022 acquired no. 1,218 treasury shares at an average unit price of € 18.8685 per share, for a total amount of € 22,977.80.
