

## Update on the execution of the buy-back programme

With reference to the buy-back programme approved by the shareholders on 5 May 2015 and launched on 14 September 2015, Sabaf S.p.A. informs that in the period between 5 December 2016 and 9 December 2016 acquired no. 4,250 treasury shares at an average unit price of € 8.8814 per share, for a total amount of €37,746.14.
