

Update on the execution of the buy-back programme

With reference to the buy-back programme approved by the shareholders on 5 May 2015 and launched on 14 September 2015, Sabaf S.p.A. informs that in the period between 23 January 2017 and 27 January 2017 acquired no. 5,251 treasury shares at an average unit price of € 10.6410 per share, for a total amount of €55,875.88.
