

Update on the execution of the buy-back programme

With reference to the buy-back programme approved by the shareholders on 5 May 2015 and launched on 14 September 2015, Sabaf S.p.A. informs that in the period between 30 May 2016 and 3 June 2016 acquired no. 5,372 treasury shares at an average unit price of € 9.8037 per share, for a total amount of €52,665.39.
