Update on the execution of the buy-back programme

With reference to the buy-back programme approved by the shareholders on 5 May 2015 and launched on 14 September 2015, Sabaf S.p.A. informs that in the period between 29 February 2016 and 4 March 2016 acquired no. 3,534 treasury shares at an average unit price of € 10.4918 per share, for a total amount of € 37,077.88.
