Update on the execution of the buy-back programme

With reference to the buy-back programme approved by the shareholders on 5 May 2015 and launched on 14 September 2015, Sabaf S.p.A. informs that in the period between 31 October 2016 and 4 November 2016 acquired no. 1,080 treasury shares at an average unit price of € 8.9395 per share, for a total amount of €9,654.61.
